
Subject: - Implementation of Government's decision on the recommendations of the Sixth Central Pay Commission- Payment of enhanced family pension for the period of 10 years in respect of Defence Civilian (including DAD, GREF and Coast Guard) who died in service prior to 01-01-2006.

Consequent upon issue of Govt. of India, Ministry of Personnel, Public Grievances & Pension, Deptt. Of Pension & Pensioners' welfare O.M.F.No.38/37/08-P&PW (A) dated, 2nd September, 2008, the enhanced family pension under Rule-54 (3) (a) (i) of C.C.S. (P), Rules 1972 shall be payable to the family of a Government servant who dies in service from the date following the date of death of the Govt. servant for a period of ten years, without any upper age limit vide Para-8.2 of the order ibid . There will be no change in the period for payment of enhanced family pension to the family in the case of death of a pensioner. It has been further clarified by that Ministry vide their O.M.F.No.38/37/08-P&PW(A)-Pt-IIdated 3rd October,2008 that the period of 10 years for payment of enhanced family pension would also apply in the case of a Govt. servant who died in service before 01-01-2006 and in respect of whom the family was receiving enhanced family pension as on 01-01-2006. These orders will, however, **not apply in case where the period of seven years for payment of enhanced family pension has already been completed on 01.01.2006** and the family was in receipt of normal family pension on that date.

2. In view of the above clarification, cases of all Govt. servants who died in service prior to 01-01-2006 and in respect of whose families were in receipt of enhanced family pension as on 01-01-2006 are required to be reviewed. Affected cases may be submitted to the officer-in-charge G-1/Civil Section of this office in the format enclosed as 'Annexure' for issue of corrigendum PPO in this regard.

3. It is requested that suitable instructions along with the copy of this circular may please be issue to all Heads of office under your administrative control to locate the affected cases from the records held in their offices for submission of the same to this office and also to give wide publicity of the above Govt. orders by displaying them on the notice boards. A copy of your instruction may please be endorsed to this office for record.
