Subject: - Implementation of Government's decision on the recommendations of the Sixth Central Pay Commission- Revision of pension of pre-2006 pensioners/family pensioners etc: **Payment of age-related additional pension.**

The procedure to be adopted by the Pension Disbursing Authority/Bank for payment of age related additional pension was circulated vide Circular no.68 dated 28-07-2009.

In para 2(III) of the said circular, it was stipulated that PDA/Bank will send one copy each of the document submitted by the pensioner/family pensioner to Pr.C.D.A. (P) Allahabad for the issue of corrigendum P.P.O. Since the pension payment order/Corr. P.P.O. is routed through Head of the office of the pensioner, the document of proof of age/date of birth is also required to be submitted to Head of Office by the PDA/Bank. As such para 2 (III) of important circular no.68 dated 28-07-2009 has been amended to read as under.

“The Pension Disbursing Authority/Bank will make payment of additional pension/family pension in the above manner, on provisional basis, up to a period of six months from the month in which the proof of age/date of birth is submitted by the pensioner/family pensioner. In such cases, the Pension Disbursing Authority/Bank **will immediately send one copy each of the document submitted by the pensioner/family pensioner to the Head of Office (H.O.O.) the particulars of whom are given in the PPO for verification and**

submission along with the Data Sheet to the Principal Controller of Defence Accounts (Pensions), Allahabad for formal authorization of the additional pension/family pension. The Pension Disbursing Authority/Bank will make payment of additional pension/family pension beyond a period of six months only on receipt of corrigendum PPO from the O/O the P.C.D.A. (P) Allahabad”.
