Therefore, for the speedy disposal of cases, Part II order of discharge stating that the reason of discharge & clause of discharge and where part II order is not available then a certificate, certifying that the individual had been invalided out/deemed to be invalid out also stating the clause of discharge may be forwarded to this office.
