2- Now Cabinet Secretariat has accorded sanction for payment of Gallantry Allowance @ 6000/- per month to Asadharan Suraksha Seva Praman Patra (ASSPP) awardees of R&AW and Directorate General of Security for life time vide letter no. 8/17/2019-EAI-1774 dated 27.08.2019 and GoI, MoD letter No. 8/17/2019-EAI-1774 dated 26.11.2019.
