
Sub: Implementation of Govt. decision on the recommendations of the VI Central Pay Commission-Revision of pension of Pre-2006 Armed Forces Pensioners/Family Pensioners.: Non providing of Annexure-IV to Defence Pensioners

Ex-Servicemen Welfare Associations are representing this office against non providing of Annexure-IV, in terms of VIth CPC, to the Defence Pensioners/ Family Pensioners

Revision of pension of Pre-2006 Armed Forces Pensioners/Family Pensioners is required to be carried out by the Pension Disbursing Authorities in terms of methodology provided for in para 4.1 and 5 of Govt. order dated 11.11.2008 circulated to all PDAs through this office circular No.397, 401, 403 dated 18.11.2008, 18.12.2008 and 02.02.2009 respectively. A ready reckoner as Annexure I, Annexure II & III is also provided in ibid circulars. PDAs are further required to report the cases of revision of pension carried out by them in the prescribed proforma i.e. Annexure IV to this office.

Para 16.4 of MOD letter No. 17(4)/2008(1)/D/(Pen/Policy) dated 11.11.2008 circulated under this office important circular No.397 dated 18.11.2008 further states that a copy of the said Annexure-IV may invariably be provided by the PDAs to the pensioner concerned for their information.

In view of the above it is requested that the pension paying branches/treasuries/DPDOs/PAOs under your jurisdiction may be instructed to provide the copy of Annexure-IV to pensioners while forwarding one copy to this office.
