As per Para 21 of GOI, MOD letter No.17 (4)/2008/ (1)/D (Pen/Policy) dated 11.11.2208 enclosed with this office Circular cited under reference, 40% of the arrears for the period 01.01.2006 to 31.08.2008 on account of updation of pension/family pension under these orders was to be paid immediately and remaining 60% of arrears shall be payable in the year 2009-2010. It was stated in this office Circular No. 397 dated 18.11.2008 quoted under reference that instructions regarding second installment of arrears will be issued in due course.

2. Government India, Ministry of Defence has since issued the orders for the release of the remaining 60 % of the arrears vide letter No. 17(4)/2008(1)/D (Pen/Pol) dated 28.08.2009 (Copy enclosed) and has authorized all the PDAs to disburse the payment thereof immediately but not latter than 30.09.2009 .It is therefore requested that all the PDAs should ensure that the remaining arrears of 60% is paid to all the pensioners immediately.

Subject: Payment of second instalment of arrears of pension on account of implementation of government's decision on the recommendations of the Sixth Central Pay Commission.

Sir,

The orders for revision of pension on implementation of the recommendations of 6<sup>th</sup> CPC were issued vide this Ministry's letter of even No. dated 11.11.08 as amended from time to time. It was provided in these orders that 40% of arrears of pension will be paid in the year 2008-09 and the remaining 60% in the year 2009-10. Accordingly, the first instalment of 40% of arrears of pension has been paid in the year 2008-09.

- 2. It has been decided that the remaining 60% of arrears of pension may now be paid to the pensioners.
- 3. All the Pension Disbursing Agencies are requested to disburse the remaining 60% of arrears of pension to Armed Forces pensioners/family pensioners latest by 30<sup>th</sup> September 2009.
- 4. This issues with the approval of Ministry of Defence (Finance) vide their UO No 1595/DFA(P) dated28 8.2009.
