**Subject:** Rates of service pension of Naiks, Corporals and Leading Seamen retiring on or after 01.01.1986.

**Reference:** This office Circular No. 220 dated 18.12.1998, No. 292 dated 07.11.2001 and No. 377 dated 07.08.2007.

As per GOI, MOD letter No. 1(1)/92/D(Pen/Sers) P-II dated 13.10.1998 Service Pension to Naik, Corporal and Leading Seaman of three services, who were discharged on or after 01.01.1986 (but before 31.12.1995) and rendered actual qualifying service of 15 years or more but less than 17 years were allowed at the same rate of pension as admissible for those discharged with actual qualifying service of 17 years with effect from 01.01.1992.

**2.** In view of the above the Naiks, Hony Naiks, TS Naiks who retired on or after 01.01.1986 with 15 years of service or more but less than 17 years of service and is/was receipt of pension or service element of disability pension alongwith disability element, their pension was to be revised on receipt of application as per Annexure 'B' attached to MOD letter dated 13.10.1998.

**3.** As you are aware that large number of cases for revision of service pension in respect of the above category of pensioners are pending at the end of Record Offices concerned for want of applications form from the affected pensioners in the format attached to MOD letter dated 13.10.1998.

4. The necessity of application form alongwith the claim in respect of affected pensioners has been dispensed with vide GOI, MOD letter No. 1(1)/92/D(Pen/Policy)Pt-II dated 24.11.2009 (copy enclosed), to enable this Office to carry out remaining outstanding revision work in respect of NKs, NKs(TS) and Hony NKs who retired on or after 01.01.1986 and before 31.12.1995 and rendered actual qualifying service between 15 to 17 years.

5. It is therefore, requested that the position may be reviewed and the remaining affected case may be sent to this Office without the application form from the pensioners on Data Sheet used for issue of Corr. PPO for revision of the pension. Alongwith the claim following information may also be submitted duly authenticated by the PAO (ORs).

- (i) Pensioner was alive/is alive.
- (ii) Date of death (if applicable)
- (iii) Last/Current PDA details with Bank A/C No., if drawing pension from PSBs.

Subject: - Rates of service pension of Naik, Corporal and Leading Seaman retiring on or after 1.1.1992.

Sir,

The undersigned is directed to refer to this Ministry's letter No. 1(1)/92/D (Pen/Sers) Pt-II dated 13<sup>th</sup> October, 1998 under which with effect from 1.1.1992, service pension to Naik, Corporal and Leading Seaman of the three Services, who were discharged on or after 1.1.1986 (but before 31.12.1995) and rendered actual qualifying service of 15 years or more but less than 17 years were allowed at the same rate as admissible for those discharged with actual qualifying service of 17 years. The revised rates of service pension under these orders were required to be notified through corrigendum PPOs by the concerned Pension Sanctioning Authorities on receipt of an application from the concerned pensioners on the prescribed format enclosed as Annexure -B to this Ministry's above said letter dated 13<sup>th</sup> October 1998.

2. It has been brought out to the notice of this Ministry that a large number of cases for revision of service pension in respect of the above category of pensioners are pending at the end of Record Offices concerned for want of application from the affected pensioners in the format prescribed under this Ministry's above quoted letter dated 13<sup>th</sup> October, 1998. The matter has been examined and it has been decided that the Pension Sanctioning Authorities shall notify the revised rate of service pension in respect of such Naik, Corporal and Leading Seaman of the three services through corrigendum PPO in each case on receipt of the requisite intimation from the Record Offices concerned viz. pensioner was alive/is alive, date of death where applicable, last/current Pension Disbursing Agencies etc. duly authenticated by their Pay Accounts Office (Other Ranks).

3. All other entries will remain unchanged.
