Subject: Implementation of Govt. decision on the recommendation of the Sixth Central Pay Commission – Revision of Pension of pre- 01.01.2006 Armed Forces Pensioners/Family Pensioners – payment of additional pension of 80 years of age and above.

As per instruction given in Para 4 of this office circular No. 408 dated 24.04.2009, Data Sheet for grant of additional pension to pensioners/family pensioners over 80 years of age are being received in this office from ROs alongwith Sheet Roll / Long Roll / Descriptive Roll.

As per existing procedure Sheet Rolls are being separated after approval of Data Sheet and handed over to the couriers of the concerned RO. During the handling over of these Sheet Rolls, it is being observed that no proper attention is being given by the concerned couriers to receive these Sheet Rolls resulting a number of Sheet Rolls are kept pending to dispatch.

Further, in the Corr. PPOs notifying additional PPOs, only Data Sheet and office copy of Corr PPOs are being kept in this office. The concerned page of Sheet Roll /other relevant documents containing exact data of birth are not available in this office Record.

Keeping in view of the abovementioned difficulties occurred in notification of additional pension to old pensioners / family pensioners, it is decided that alongwith the claim the following documents may please be submitted to this office for notification of Corr. PPOs.
