2. With the issue of ibid Govt. order, the rate of 'Jangi Inam' has been enhanced to Rs500/= p.m. to all categories of Jangi Awardees and their legal heirs of World War I (two lives) and World War II (one life only).
3. The other terms and conditions governing the grant of 'Jangi Inam' will remain unchanged.
4. These orders will take effect from 30.03.2011.
5. The payment of 'Jangi Inam' at enhanced rate will be subject to all other conditions governing the payment of Gallantry Award. The payment may please be made at the enhanced rate after determining the eligibility in each case by a careful scrutiny of PPO notifying the award.


Subject : Enhancement of monetary allowance attached to 'Jangi Inam'(a Pre-Independence Gallantry Award)

I am directed to refer to this Ministry's letter No 7(34)/2006-D(AG) dated 13 Oct. 2006 and 7(67)/92/D(AG) dated 18 May 1995 on the above subject and to convey the sanction of the President to the enhanced payment of Rs 500/- P.M. to all categories of Jangi Awardees and their legal heirs of World War I(Two lives) and World War II(one life only) **with effect from the date of issue of this letter.**
