**Subject:** Revision of pension w.e.f 01.07.2009 in terms of GOI, MOD Letter dt. 08.03.2010 due to re-grouping of certain trades.

**Reference:** This office Circular No. 430 dated 10.03.2010.

Complaints/ representations are being received in this office from various sources regarding the correct rate of revised pension that would be admissible to PBOR wef 01.07.2009 in terms of Para 7.3 of above cited circular who were discharged during the period 01.01.1973 and 09.10.1997 while serving in certain trades which were later regrouped.

In terms of Para 1.1 of GOI MOD letter dt. 08.03.2010, all pre-10.10.1997 pensioners are to be brought at par with post-10.10.1997 PBOR pensioners. PBOR of Army who were discharged on or after 10.10.1997 while serving in under mentioned trades in the Group 'D' or Group 'E' have been regrouped in 'Z' and 'Y' respectively wef 10.10.1997.

<u>Trades</u>	<u>Equated to wef 10.10.1997</u>
Religious Teachers (RT), Lab Asstt in AMC, Dresser in RVC and Driver MT	Pay Group 'E' equated to Group 'Y'
Sowar, Horse Cart Rider in Armored Corps, Cook Hospital in AMC, upholster in EME, Farrier in AVC and Cook Special	Pay Group 'D' equated to Group 'Z'

Now, it has been observed that difficulty in revision of pension of individuals in above trades has arisen due to non indication of trade in PPO in which individual was discharged/ invalided out. This issue has been examined in this office and it has been decided that in such mismatched cases Corr PPO is to be issued when any such type of case is brought to notice of this office by the PDA on case to case basis.

In view of above, it is requested that such type of cases where PDAs are unable to revise pension due to change of group, the same may be referred to this office through Record Office (who in turn will provide certificate/ document showing trade of individual at the time of entry and also at the time of discharge) so that necessary corr PPO, if necessary, may be issued in case to case basis.
