**Subject:** - Rationalization of causality pensionary awards of Armed Forces Officers and Personnel Below Officers Rank (PBOR)  
Implementation of Govt decision on recommendations of VI CPC  
– Special benefits in case of death and disability in service prior to 01.01.2006 regarding.

**Reference:** This Office Circular No. 456 dated 18.03.2011.

Kindly refer to this office circular cited under reference under which rates/ tables for modified parity of Special/Liberalized/Family Pension and Disability/ War injury element for various ranks have been prepared and circulated. In the said Circular there is no table for Hony rank of Naik, Hony Havildar and Havildar granted Hony rank of Nb-Subedar.

2. References have been received from various PDAs seeking clarifications on above issue. In this connection it is clarified that in terms of Para 3, 5, 9 and 11 of MOD letter dated 15.02.2011, which has been circulated under this office circular No. 456 dated 18.03.2011, minimum guaranteed amount of Special/Liberalized Family pension and Disability/War Injury element shall be calculated with reference to newly introduced pay structure **corresponding to the pre-revised scale held by the Armed Forces personnel at the time of retirement/ discharge/ invalidment.**

In view of above it is hereby clarified that:-

Since Hony Rank of Naik, Havildar and Havildar holding Hony rank of Nb Sub draw pay in the pay scale of Sepoy, Naik and Havildar respectively, therefore they should be entitled for modified parity with reference to substantive rank held at the time of retirement / discharge / invalidment except for the Naik (TS) who draw pay Scale of Naik and therefore should be entitled for modified parity will referred to Naik rank.

3. All other subsidiary payment instructions will remain the same, as already circulated vide this office circular No. 456 dated 18.03.2011. It is requested that the cases for revision as per these clarifications / orders may please be reviewed and the affected cases may please be revised accordingly.

4. It is further requested that a copy of these clarifications/orders may please be circulated to all Pension Disbursing Authorities (DPDOs/ Paying Branches / Treasuries / PAOs etc) under your jurisdiction to ensure the revision at the earliest.
