**Subject:** Cancellation of “S” and “DE” series PPO’s in respect of the individual discharged under LMC and Re-instated under Hon’ble High Court Judgment dated 20.11.2008.

**Reference:** - Adjutants’ General’s Branch letter No B/10201/06-08/ Vol-II /MP-3(PBOR) dated 02.12.2008.

The PPO notifying the pensionary awards in respect of the individuals discharged under Low Medical Category (LMC) and have been re-instated as per the Honorable High Court Judgment, are to be cancelled.

2. In order to issue a Corrigendum PPO canceling the PPO notifying the Service Pension and Disability Pension, the ROs are requested to furnish the LPC Cum Data Sheet. The existing filling instructions as well as LPC Cum Data Sheet (Rev) already used in service pension corrigendum system may be used, for the purpose. However, Column for filling of “DE” series PPO’s detail, is not available in the existing LPC Cum Data Sheet (Rev). This authentic “DE” series PPO’s detail may be written below Column No. 5 of Cage I of the LPC Cum Data Sheet by the ROs. This will co relate with the “S” PPO series. The Corrigendum PPO will cancel both the PPOs, “S” series PPO as well as the “DE” series PPO.

3. The RO may submit the LPC Cum Data Sheets(Rev) in batches Year wise with the remarks on the top “**LMC Court Cases Cancellation**” to the

Officer Incharge EDP Manual Service Wing (Corrigendum ) with the following supporting documents:-

- (i) Original Copy of the PPO
- (ii) RO's Copy of the PPO.
- (ii) Pension Certificate in original
- (i) Proof of the amount deposited in the Government Treasury.
- (ii) Confirmation from the PDA regarding stoppage of pension.
4. Necessary endorsement regarding re-instatement and cancellation of the PPO in the sheet Roll may be made by the ROs at their end.


